4	Section 8104(a) of title 38, United States Code, is
5	amended—
6	(1) in paragraph $(3)(A)$ , by striking
7	"\$20,000,000" each place it appears and inserting
8	"the amount specified in paragraph (4)"; and
9	(2) by adding at the end the following new
10	paragraph:
11	"(4)(A) The amount specified in this paragraph is
12	\$30,000,000, as adjusted pursuant to this paragraph.
13	"(B)(i) The Secretary shall develop, through regula-
14	tions, a mechanism to adjust the amount under subpara-
15	graph (A) to account for relevant factors relating to con-
16	struction, cost of land, real estate, economic conditions,
17	labor conditions, inflation, and other relevant factors the
18	Secretary considers necessary to ensure such amount
19	keeps pace with all economic conditions that impact the
20	price of construction projects, to include planning, man-
21	agement, and delivery of the project.
22	"(ii) In developing the mechanism under clause (i),
23	the Secretary may—
24	"(I) use a mechanism or index already relied
25	upon by the Department for other relevant pro-

grams, a mechanism or index used by another Fed-

1 eral agency, or a commercial mechanism or index if 2 such mechanism or index satisfactorily addresses the 3 intent of this subparagraph; or 4 "(II) create a new mechanism or index if the 5 Secretary considers it appropriate and necessary to 6 do so. 7 "(C)(i) Not less frequently than once every two years, 8 the Secretary shall— 9 "(I) adjust the amount under subparagraph 10 (A); or 11 "(II) publish a notice in the Federal Register 12 indicating that no adjustment is warranted. 13 "(ii) Not later than 30 days before adjusting an amount pursuant to clause (i)(I) or publishing a notice 14 15 pursuant to clause (i)(II), the Secretary shall notify the Committee on Veterans' Affairs and the Committee on Ap-16 propriations of the Senate and the Committee on Vet-17 18 erans' Affairs and the Committee on Appropriations of the 19 House of Representatives. 20 "(D) The Secretary shall determine a logical schedule 21 for adjustments under this paragraph to take effect so 22 that the amounts for and types of construction projects 23 requested by the Department in the budget of the Presi-24 dent under section 1105(a) of title 31 are consistent with

25 the threshold for construction projects as so adjusted.".
