7	The Committee met, pursuant to notice, at 3:00 p.m., in
8	Room 301, Russell Senate Office Building, Hon. Jon Tester,
9	Chairman of the Committee, presiding.
10	Present: Senators Tester, Murray, Sanders, Brown,
11	Blumenthal, Hirono, Sinema, Hassan, Moran, Boozman, Tillis,
12	Blackburn, Cramer, and Tuberville.
13	OPENING STATEMENT OF CHAIRMAN TESTER
14	Chairman Tester. I want to call this hearing to order.
15	I know Senator Moran is on his way but we will keep going.
16	Today we are going to consider nominations for four key
17	positions at the VA as well as a number of bills on behalf
18	of veterans and their families, including comprehensive
19	legislation on behalf of toxic exposure veterans. For
20	decades, both VA and Congress have been either unable or
21	unwilling to address the issue of toxic exposure in a
22	comprehensive manner. Today we are going to take that
23	critical first step.
24	The COST of War is comprehensive legislation that
25	establishes a framework to fundamentally address the impacts

- 1 of toxic exposure on future generations of veterans. It
- 2 also provides much needed care and benefits to previous
- 3 generations of veterans already suffering from the impacts
- 4 of exposure during their military service, from those
- 5 serving in the jungles of Vietnam to those exposed to burn
- 6 pits in Iraq or Afghanistan.
- 7 There is no denying that this is an incredibly complex
- 8 issue that comes with a high price. If it was easy it would
- 9 have been done long ago. I am under no illusion that the
- 10 bill before us is the final product, but our actions today
- 11 will send an important message to the public, to the
- 12 veterans, in particular, that we are serious about
- 13 addressing toxic exposure in a meaningful way, and we are
- 14 starting today. It is a critical first step that serves as
- 15 a baseline from which we can work on a bipartisan basis.
- To that end, my commitment to the Ranking Member is
- 17 that I will not advance the bill to the floor without his
- 18 consent, and I commit to all of you to work in a transparent
- 19 and bipartisan manner to address any concerns related to the
- 20 cost or potential negative impacts on the VA. That means
- 21 forcing the VA, OMB, CBO, and others to the table so that we
- 22 can have as much information as possible before we make our
- 23 final decision. And after negotiating a path forward with
- 24 the House and the administration, that means convening this
- 25 Committee in a public setting so you will have another

- 1 opportunity to ask questions and share your thoughts.
- This bill, the COST of War Act, represents a
- 3 culmination of bipartisan efforts to provide health care and
- 4 compensation to generations of toxic exposure veterans. We
- 5 made a promise to the men and women who fought our wars that
- 6 Congress would fight for them. It is time that we settle
- 7 our debts and finally address this hidden cost of war.
- 8 Veterans have waited decades for VA and Congress to act.
- 9 They should not have to do that. If we get this bill done,
- 10 they will not have to wait any longer.
- 11 With that I turn it over to Ranking Member Moran. Over
- 12 to you.
- 13 OPENING STATEMENT OF SENATOR MORAN
- 14 Senator Moran. Chairman Tester, thank you. As you may
- 15 have said before I walked in the door we are considering
- 16 four nominations today and six pieces of legislation. I
- 17 support the nominees and five of our six bills, and am
- 18 pleased to vote those out of Committee.
- 19 The COST of War Act is trying to deliver on a promise
- 20 this country made, and, Mr. Chairman, I agree with a
- 21 sentiment that you expressed, which is the decision to spend
- 22 money, provide resources and assistance to our veterans is
- 23 made the day we ask them to go into battle. Our job is to
- 24 figure out how to meet their needs. Our job is to figure
- 25 out how to do that in a way that makes sense, that does not

- 1 damage other veterans and their interests, and that makes
- 2 certain that our dollars are spent effectively and
- 3 efficiently.
- 4 If you serve in the military and you are injured or
- 5 made ill because of that service you should not go without
- 6 health care for those conditions and you should be
- 7 compensated for loss of income due to those injuries or
- 8 illness.
- 9 Unfortunately, the current process is not fulfilling
- 10 the promise that we made to veterans who are sick due to
- 11 toxic exposure. I am committed to fixing this process so
- 12 that veterans can get the care and benefits they need, they
- 13 have earned, and it is why I will vote to advance the COST
- 14 of War Act today.
- 15 But this bill, in my view, still needs a lot of work.
- 16 Crucially, we do not know the cost or impact of the
- 17 legislation and how it will impact or affect the operations
- 18 of the Department of Veterans Affairs. We do not know, for
- 19 example, what this legislation means to the backlog of over
- 20 300,000 claims. It would have been my preference for this
- 21 Committee to resolve those issues before voting on whether
- 22 or not it is ready for debate on the Senate floor.
- 23 This Committee has been, for a long time, for as long
- 24 as I have been involved in it, an example of how both sides
- 25 can set aside their differences and work together to pass

- 1 legislation with the goal of supporting our nation's
- 2 veterans. I talk at home to my constituents, and it is the
- 3 place that I would tell them is the last, perhaps, bastion
- 4 of bipartisanship, and I want to keep it that way. It is
- 5 certainly my desire today to see that that cooperation
- 6 between the majority and the minority continue.
- 7 Chairman Tester committed to address the outstanding
- 8 concerns that Committee members have before any
- 9 consideration of this bill by the full Senate, so today,
- 10 despite the vote, there is still much work to be done, much
- 11 work for us to complete as a Committee, before we truly have
- 12 a solution that provides the help our veterans are entitled
- 13 to and need.
- 14 We must get formal views from the administration and
- 15 the detailed cost estimates from the CBO and the OMB. I
- 16 would feel much more comfortable if the Department of
- 17 Veterans Affairs, prior to today's mark-up, had provided
- 18 those views. They have declined to do so, and perhaps this
- 19 effort on our part today will cause them to respond
- 20 appropriately.
- 21 We need to understand what actions VA has the authority
- 22 to do now, and this legislation, how it would affect
- 23 veterans currently receiving care and benefits. My goal is
- 24 to make certain that in directing the VA to provide care for
- 25 additional veterans we do not diminish their ability to care

- 1 for all veterans.
- 2 Again, I will support this legislation today with the
- 3 commitment that we will work together, work in the best
- 4 interest of veterans, to get this legislation right.
- 5 Thank you, Mr. Chairman.
- 6 Chairman Tester. Thank you, Senator Moran, and I do
- 7 not disagree with anything that you said, so we will move
- 8 forward.
- 9 I want to thank everybody for being here. I know it is
- 10 busy, but we have a quorum. We have four nominations and
- 11 six legislative agenda items. But first, with your consent,
- 12 Senator Moran, I want to open the floor to discussion on the
- 13 COST of War Act, and consider any amendments, then hold a
- 14 voice vote on the bill, followed by a separate voice vote on
- 15 the four nominations and the five remaining legislation
- 16 items en bloc. Are you okay with that?
- 17 Senator Moran. Please proceed, Mr. Chairman.
- 18 Chairman Cardin. Okay. The floor is now open for
- 19 discussion, and I want to recognize Senator Blackburn
- 20 because I understand she has a commitment.
- 21 Senator Blackburn. Thank you so much, and yes, I do
- 22 have a commitment with my grandson, so thank you for letting
- 23 me go first.
- 24 First let me say I support dealing with the toxic
- 25 exposure issue and have worked on K2 legislation to deal

- 1 with some of our Special Forces members that are at Fort
- 2 Campbell. But this is not the Committee mark-up that these
- 3 veterans deserve.
- 4 The True Cost of War Recognition Act will require the
- 5 VA to completely reshape the way it processes toxic exposure
- 6 claims and will establish a presumption of service
- 7 connection for multiple diseases. Does the VA have the
- 8 capacity to absorb the provisions in this legislation? They
- 9 have a significant backlog, so probably not. How long will
- 10 it take the VA to fully implement it? They have not been
- 11 able to deal with Community Care. They have not been able
- 12 to deal with electronic records.
- 13 These are simple answers to questions that Committee
- 14 has yet to receive from the VA, because we have chosen to
- 15 not put the work in on the front end. It is safe to say
- 16 that this bill would likely exacerbate the growing claims
- 17 backlog caused by the Agent Orange Veteran Exposure bill and
- 18 the pandemic. Today, the claims backlog is 188,000. On May
- 19 12th, the VA testified before this Committee and told
- 20 Chairman Tester that the claims backlog could reach 240,000
- 21 by August.
- 22 So when will the veterans included under this bill see
- 23 their first benefit? If we cannot answer that simple
- 24 question we are giving veterans all across this nation a
- 25 false hope. Our veterans make sacrifices for this nation,

- 1 and they deserve the high-quality care that they have been
- 2 promised, at the right place and at the right time, to
- 3 alleviate the burdens they may carry physically,
- 4 spiritually, and emotionally.
- 5 That is why I have submitted an amendment to allow
- 6 veterans covered under this bill to be immediately eligible
- 7 to seek services through the Veterans Community Care
- 8 Program. This amendment will provide veterans with access
- 9 to the care they deserve, in a timely manner. That is
- 10 something that we all should agree on.
- 11 Mr. Chairman, at this time I move to withdraw the
- 12 amendment to allow you and the Ranking Member to smooth out
- 13 differences on how to address cost and operational concerns
- 14 and to receive VA official views to inform the Committee on
- 15 additional work that is needed for this bill, and to find a
- 16 way to provide this care that is expected of these veterans
- 17 in a timely manner.
- 18 Chairman Tester. Thank you, Senator Blackburn.
- 19 Anybody else have discussion or an amendment? Senator
- 20 Tillis. No? What is that? I think Senator Blackburn is
- 21 done, so you are up next.
- 22 Senator Tillis. Thank you, Mr. Chairman. First I just
- 23 want to thank you for the reassuring comments in your
- 24 opening statement and for working with the Ranking Member on
- 25 really just being sensitive to the concerns I think that we

- 1 all share. I appreciate that. I also appreciate the
- 2 minority and majority staff, particularly the majority staff
- 3 that have been working with my office.
- 4 I also want to thank the members of this Committee for
- 5 passing out, on a unanimous basis, the TEAM Act, in the last
- 6 Congress, and I appreciate your support along the way. The
- 7 TEAM Act is part of the COST of War Act, but it goes beyond
- 8 that. And I think that the issues or the concerns we have
- 9 are really rooted in knowing what the total cost of the COST
- 10 of War bill was going to be.
- 11 The reason I put together an amendment--I intend to
- 12 withdraw it--is we have got an odd circumstance when we are
- 13 talking about a bill that could be, once we get a CBO score,
- 14 in the hundreds of billions, the extreme, \$1 trillion. And
- 15 the purpose of the amendment, which I would not ask for a
- 16 vote on today, would be to have the VA Secretary certify
- 17 that it would not disrupt providing services that they are
- 18 already responsible for. We cannot have this diminish,
- 19 given them almost an unfunded mandate that almost certainly
- 20 has to come from somewhere.
- 21 But I think that the process that you have used to
- 22 understand the concerns and the commitment that we have to
- 23 not move the bill until we get answers, most importantly, a
- 24 definitive answer from the Department, who seems to think
- 25 that their study could produce result that would actually

- 1 not require any congressional action, I find that suspect.
- 2 But let's just go through that process and work on, you
- 3 know, in the tradition of this Committee, a good bipartisan
- 4 outcome. So I will be supporting the COST of War Act. I am
- 5 withdrawing my amendment, and I look forward to supporting
- 6 the other amendments that may come forth. Thank you.
- 7 Chairman Tester. Thank you, Senator Tillis. I
- 8 appreciate your leadership on this issue.
- 9 Does anybody else have an amendment?
- 10 [No response.]
- 11 Chairman Tester. Comment?
- [No response.]
- 13 Chairman Tester. All right. Hearing no further
- 14 discussion we will proceed with a voice vote on the COST of
- 15 War Act of 2021, if there is no objection.
- This is a voice vote, so all in favor, say aye.
- [Chorus of ayes.]
- 18 Chairman Tester. Opposed, nay.
- 19 [No response.]
- 20 Chairman Tester. The ayes appear to have it. Agenda
- 21 Item 5 is ordered reported.
- We are now going to turn to the four nominations.
- 23 Moving first to Agenda Item 1, is there any discussion
- 24 on the nomination of Donald M. Remy to be Deputy Secretary
- 25 of Veterans Affairs?

- 1 [No response.]
- 2 Chairman Tester. Hearing no discussion, if there is no
- 3 objection we will continue to a voice vote.
- 4 All those in favor say aye.
- 5 [Chorus of ayes.]
- 6 Chairman Tester. Opposed, nay.
- 7 [No response.]
- 8 Chairman Tester. The motion carries. Agenda Item 1 is
- 9 ordered reported.
- 10 Now we are going to move to Agenda Item 2. Is there
- 11 any discussion on the nomination of Matthew T. Quinn to be
- 12 Under Secretary of Veterans Affairs for Memorial Affairs?
- [No response.]
- 14 Chairman Tester. Hearing no discussion we will go to
- 15 the voice vote.
- 16 All in favor of Matthew Quinn to be Under Secretary of
- 17 Veterans Affairs for Memorial Affairs say aye.
- [Chorus of ayes.]
- 19 Chairman Tester. Opposed, nay.
- [No response.]
- 21 Chairman Tester. The ayes appear to have it. Agenda
- 22 Item 2 is ordered reported.
- Now moving to Agenda Item 3. Is there any discussion
- 24 on the nomination of Maryanne Donaghy to be Assistant
- 25 Secretary of Veterans Affairs for the Office of

- 1 Accountability and Whistleblower Protection?
- 2 [No response.]
- 3 Chairman Tester. Hearing no discussion, if there is no
- 4 objection we will continue to a voice vote.
- 5 All in favor say aye.
- 6 [Chorus of ayes.]
- 7 Chairman Tester. Opposed, nay.
- 8 [No response.]
- 9 Chairman Tester. The Agenda Item 3, nomination of
- 10 Maryanne Donaghy as Assistant Secretary of Veterans Affairs
- 11 is reported.
- 12 Now to Agenda Item 4. Is there any discussion on the
- 13 nomination of Patricia Ross to be Assistant Secretary of
- 14 Veterans Affairs for the Office of Congressional and
- 15 Legislative Affairs?
- 16 [No response.]
- 17 Chairman Tester. Hearing no discussion we will go to a
- 18 voice vote, without objection.
- 19 All those in favor say aye.
- [Chorus of ayes.]
- 21 Chairman Tester. Opposed, nay.
- [No response.]
- 23 Chairman Tester. Agenda Item 4 is ordered reported.
- Now we have four remaining bills. I want to turn to
- 25 Agenda Items 6 through 10. Having no amendments to Agenda

- 1 Items 6 through 10 I would like to now proceed en bloc with
- 2 those--I am sorry, with those five items, which include S.
- 3 89, the Committee Print of Ensuring Survivor Benefits During
- 4 COVID-19 Act of 2021; S. 189, the Committee Print of the
- 5 Veterans' Disability Compensation COLA Act of 2021; S. 895,
- 6 the Committee Print of the Hire Veterans Health Heroes Act
- 7 of 2021; S. 1031, a bill to require the Comptroller General
- 8 of the United States to conduct a study on disparities
- 9 associated with race and ethnicity with respect to certain
- 10 benefits administered by the Secretary of Veterans Affairs,
- 11 and for other purposes; and S. 1095, the Colonel John M.
- 12 McHugh Tuition Fairness for Survivors Act of 2021.
- I would ask that there is a motion for these five
- 14 agenda items to be reported favorably en bloc.
- 15 Senator Moran. Mr. Chairman, I so move to report
- 16 favorably these five items en bloc.
- 17 Chairman Tester. Second?
- 18 Senator Blumenthal. Second.
- 19 Chairman Tester. Is there any discussion on these
- 20 items before we vote?
- [No response.]
- 22 Chairman Tester. Hearing no discussion we will
- 23 continue with the en bloc voice vote.
- 24 All those in favor of reporting Agenda Items 6 through
- 25 10 favorably say aye.

- 1 [Chorus of ayes.]
- Chairman Tester. All opposed say nay.
- 3 [No response.]
- 4 Chairman Tester. The ayes appear to have it. Agenda
- 5 Items 6 through 10 are ordered reported.
- Before I close, does anybody have a comment they would
- 7 like to make?
- 8 I want to express my appreciation to--
- 9 Senator Boozman. Mr. Chairman?
- 10 Chairman Tester. Go ahead.
- 11 Senator Boozman. The only thing I would like is to
- 12 have a statement put in the record, and I do appreciate the
- 13 great work that you and our Ranking Member have done in
- 14 getting us moving forward, and we look forward to gathering
- 15 a little bit more information and hopefully getting this
- 16 thing done.
- 17 Chairman Tester. Without objection, the statement for
- 18 the record is entered, and I echo those comments towards
- 19 you, Senator Boozman. You have been very good on this
- 20 Committee.
