8	The committee met, pursuant to notice, at 10:08 a.m.,
9	in Room 418, Russell Senate Office Building, Hon. Bernard
10	Sanders, chairman of the committee, presiding.
11	Present: Senators Sanders, Brown, Begich, Blumenthal,
12	Hirono, Burr, Johanns and Boozman.
13	OPENING STATEMENT OF CHAIRMAN SANDERS
14	Chairman Sanders. Okay. Let us convene this markup.
15	We have got a seven members. We are waiting for one more.
16	What we are going to do is today vote on the
17	nominations of Sloan Gibson, Linda Schwartz, and Constance
18	Tobias; and then we are going to move toward the legislative
19	agenda which is S. 932, S. 1262, S. 1556, S. 1581, S. 1593,
20	and S. 1604.
21	While we are waiting for our eighth member, let me just
22	say a few words. It is my belief that everybody on this
23	Committee regardless of political party is doing everything
24	he or she can to protect the interest of our veterans, and I
25	intend to do everything I can to run this Committee on as

- 1 much of a bipartisan basis as I can.
- I just did want to mention in that regard where I think
- 3 we are making some progress is that a few weeks ago when we
- 4 had our legislative hearing, you all will recall that Dan
- 5 Coats came up with that rather unusual and rather morbid
- 6 case. I am happy to tell you that I think that was a
- 7 concern of his.
- 8 We got that UCed last night. So, we moved that pretty
- 9 quickly, and I want to try to do those things. Where we
- 10 have agreements, let us move it; and I think Senator Coats
- 11 was pleased by that.
- 12 All of us or many of us knew Bill Young.
- 13 Senator Burr, I know you knew Bill Young.
- I knew him when I was in the House. He was a very
- 15 decent guy and a very good Congressman. Sadly, he passed
- 16 away a short time ago.
- 17 Senator Nelson was here asking that we move toward
- 18 naming a VA facility in Florida after him, and I am happy to
- 19 tell you that has moved through this body as well. So, we
- 20 are moving pretty quickly on those things.
- 21 Yesterday, Senator Boozman and I chatted about an issue
- 22 that he has been concerned about, and I think he has brought
- 23 forth a good idea dealing with how we treat folks with TBI,
- 24 a huge issue in this country. With luck, we are going to
- 25 get that passed today as well.

- One of the issues that we are going to be touching on
- 2 is an issue that Mark Begich and Senator Boozman have worked
- 3 on I think for a while, and that is advance appropriations.
- 4 It is an issue that not everybody agrees with.
- 5 The bottom line there is we did this for VA health care
- 6 several years ago. There is pretty good consensus that it
- 7 has worked well. Many of us were deeply concerned that
- 8 during the shutdown there was a possibility that we were a
- 9 week, 10 days away from veterans not getting their
- 10 disability checks or their pensions which would have been an
- 11 outrage and something nobody on this Committee or I think
- 12 anybody in the Congress would have been happy about. That
- 13 would have been unacceptable.
- 14 So, what we are going to be discussing today and voting
- on is an advanced appropriations bill that was worked on by
- 16 Senator Begich and by Senator Boozman.
- 17 We have health care legislation which, among other
- 18 things, is going to make it easier for veterans to get into
- 19 the VA. It would extend the period of time individuals who
- 20 served in combat are eligible to enroll in VA health care
- 21 from five years to 10 years.
- 22 I think we all remember that folks who have served
- 23 overseas in Iraq, Afghanistan have a five-year period of
- 24 free health care. That is rolling out. We are going to
- 25 extend that to 10 years.

- 1 We are also going to look at a pilot project for dental
- 2 care. We are also going to be voting and examining a
- 3 significant employment bill. Employment, unemployment for
- 4 veterans remains too high in this country and we are going
- 5 to try to address that issue. We are also going to
- 6 strengthen the SCRA and that has to do with the
- 7 Servicemembers Civil Relief Act.
- 8 So, those are some of the issues we are going to be
- 9 touching on today and we will be moving along as quick as
- 10 our eighth member.
- But, Senator Burr, did you want to make some comments?
- 12 Senator Burr. Well, thank you, Mr. Chairman, and I
- 13 want to start by briefly mentioning two bills as well that I
- 14 sponsored that are being considered today.
- The first is the Veterans Dialysis Pilot Program Review
- 16 Act. This bill aims to ensure that VA is thoroughly
- 17 evaluating its ongoing dialysis pilot before it rolls out
- 18 that program nationally so we can first see if a national
- 19 program would be in the best interest of veterans and
- 20 taxpayers.
- 21 The other is the Improving Quality of Care within the
- 22 Department of Veterans' Affairs Act. This would address
- 23 many of the quality management problems at VA that have led
- 24 to patient harm and death including the misuse of insulin
- 25 pens, outbreak of Legionella, and the delays in patient

- 1 care.
- 2 These bills provide straightforward solutions to the
- 3 ongoing issues, and I am glad that the Committee has an
- 4 opportunity to act on them today.
- 5 Mr. Chairman, before I turn it back to you, I want to
- 6 make a few general comments about the packages of
- 7 legislation on today's agenda. These bills would make
- 8 changes to a wide range of VA programs but the Committee has
- 9 not held oversight hearings to look at how well many of
- 10 these programs are working and whether there are any gaps or
- 11 inefficiencies that should be fixed.
- 12 At the legislative hearing when these bills were
- 13 supposed to be discussed, there were three dozen bills on
- 14 the agenda, many more than we could consider in depth.
- We still do not have the views of relevant agencies on
- 16 many of the provisions in these bills. We do not have
- 17 complete estimates on how much all of this would cost; and
- 18 even though some of the changes in these bills will likely
- 19 cause of billions, there are no offsets to pay for them.
- 20 That spending would be in addition to the \$13 billion worth
- 21 of bills that the Committee acted on in July that were also
- 22 not paid for.
- 23 For these and for other reasons, I cannot support most
- 24 of the bills on the agenda at this time. As we move
- 25 forward, I hope the Committee will continue to take steps to

- 1 understand what changes are truly needed and will find ways
- 2 to pay for them.
- I thank the chair and I reserve my right to file
- 4 minority views with respect to any of the bills on today's
- 5 agenda.
- 6 Chairman Sanders. Senator Burr, thanks very much.
- 7 We now have a quorum. I think this is a busy day for
- 8 many members. So, my hope is that we can move the process
- 9 along as quickly as possible.
- 10 At this point I would invite a motion on the pending
- 11 business, the nominations, Senator Brown.
- 12 Senator Brown. Mr. Chairman, in accordance with the
- 13 Committee's practice to vote on agenda items a soon as a
- 14 quorum of eight is present, I made the following motion.
- 15 I moved the Committee favorably report the nominations
- 16 of Sloan Gibson to be Deputy Secretary of Veterans' Affairs;
- 17 Linda Schwartz as Assistant Secretary of Veterans' Affairs
- 18 for Policy and Planning; and Constance Tobias to be chair of
- 19 the Board of Veterans' Appeals, Department of Veterans'
- 20 Affairs.
- 21 Senator Burr. Mr. Chairman.
- 22 Chairman Sanders. Senator Burr.
- 23 Senator Burr. Mr. Chairman, I am happy to have a voice
- 24 vote on Sloan Gibson and Linda Schwartz. I would require a
- 25 roll call vote on Tobias and would ask unanimous consent

- 1 that we not take up the nomination of her today, that we
- 2 wait until some document requests are fulfilled.
- 3 Chairman Sanders. I am going to object to that point,
- 4 Senator Burr. But if it is okay, can we do a voiceover now
- 5 on the two?
- 6 Senator Burr. On Sloan Gibson and Ms. Schwartz?
- 7 Chairman Sanders. Yes.
- 8 Senator Burr. Yes.
- 9 Chairman Sanders. Okay. Do you want to make that
- 10 motion?
- 11 Senator Burr. So moved.
- 12 Chairman Sanders. Okay. So, we now have a motion for
- 13 a voice vote on Sloan Gibson to be Deputy Secretary of
- 14 Veterans' Affairs, Linda Schwartz to be Assistant Secretary
- 15 of Veterans' Affairs.
- 16 All those in favor please say aye.
- [A chorus of ayes.]
- 18 Chairman Sanders. All of those opposed.
- 19 [No response.]
- 20 Chairman Sanders. The ayes have it.
- Now, we are going to do a roll call vote on Constance
- 22 Tobias.
- 23 Senator Burr. Mr. Chairman.
- 24 Chairman Sanders. Yes.
- 25 Senator Burr. If I may speak on this nomination.

- 1 Chairman Sanders. Sure.
- Senator Burr. As you know, I have asked that the
- 3 nomination hearing be postponed with regard to the nominee
- 4 for Chairman of the Board of Veterans' Appeals because we
- 5 have not received documents that the Committee has been
- 6 requesting since last year. We still have not received
- 7 those documents. So, I believe it is premature to include
- 8 this nominee on today's agenda.
- 9 To put this in perspective, the nominee has been asked
- 10 at least six times since last July to submit documents
- 11 regarding a specific matter, including requests for any and
- 12 all such documents.
- 13 At this point it is clear that the relevant documents
- 14 do exist and that they have not yet been provided to the
- 15 Committee. As I have said before, I think it may be
- 16 necessary to have another hearing once we receive those
- 17 documents so we can ask informed questions that we learn
- 18 from those documents.
- 19 But I also think the situation raises broader
- 20 questions. Whoever is confirmed to serve as chairman of the
- 21 board would be responsible for ensuring that the Committee
- 22 receives timely, thorough responses to our requests for
- 23 information about the board's activities.
- As I mentioned at the nomination hearing, this
- 25 Committee is already facing long delays and continued

- 1 frustrations in trying to get information from VA. So, I
- 2 think we need to consider whether this type of response we
- 3 could expect to our requests for information if the nominee
- 4 is confirmed.
- 5 But regardless of those concerns, we should not move
- 6 forward with this nomination until we have received complete
- 7 answers to our questions.
- 8 So, Mr. Chairman, I realize you object to the unanimous
- 9 consent request to delay consideration but I would urge my
- 10 colleagues, this is premature, and this is not a document
- 11 request that was made last week or last month. It was made
- 12 last year.
- 13 Thank you, Mr. Chairman.
- 14 Chairman Sanders. Senator Burr and I have a difference
- 15 of opinion on this but let us go forward with the roll call
- 16 vote on Constance Tobias to be Chairperson of the Board of
- 17 Veterans' Appeals.
- 18 Clerk, will you call the roll please?
- 19 The Clerk. Mr. Rockefeller.
- 20 Chairman Sanders. Mr. Rockefeller votes age by proxy.
- 21 The Clerk. Mrs. Murray.
- Chairman Sanders. Mrs. Murray votes age by proxy.
- The Clerk. Mr. Brown.
- 24 Senator Brown. Aye.
- 25 The Clerk. Mr. Tester.

- The Clerk. On this vote, the ayes are 8. The nays are
- 23 six. The nomination is agreed to.
- Chairman Sanders. Okay. Let us move now to the
- 25 legislative agenda, and my understanding is that, and,

- 1 Senator Burr, correct me if I am wrong but you are in
- 2 agreement that we can do a voice vote on the omnibus.
- 3 Senator Burr. Correct.
- 4 Chairman Sanders. All right. Okay. And the omnibus
- 5 is 1581. Okay.
- 6 Senator Brown.
- 7 Senator Brown. I move that the Committee order
- 8 favorably report to the Senate the six legislative items on
- 9 today's agenda and move that the reporting or approval of
- 10 these items be subject to any amendments or motions
- 11 subsequently adopted and further move the Committee staff be
- 12 directed to prepare the Committee reports on these items and
- 13 make necessary clerical, technical, and conforming changes
- 14 including changes necessary to conform with the Budget Act.
- 15 Senator Burr. Mr. Chairman.
- 16 Chairman Sanders. Senator Burr.
- 17 Senator Burr. Mr. Chairman, if I could just add, I am
- 18 supportive of this bill today but I want to make it clear
- 19 that there is still work to be done to make sure that we
- 20 take stakeholder input into account.
- 21 So, as we get the views of relevant Committees and we
- 22 make sure that any costs in this bill are, in fact, paid
- 23 for.
- 24 And I thank the chair.
- Chairman Sanders. Okay. We are now voting on the

- 1 omnibus bill. That is S. 1581.
- 2 All of those in favor please say aye.
- 3 [A chorus of ayes.]
- 4 Chairman Sanders. All those opposed say no.
- 5 [No response.]
- 6 Chairman Sanders. The ayes appear to have it. The
- 7 ayes do have it. That legislation is passed.
- Now, we will proceed to the Committee print of S. 932.
- 9 Is there any discussion on this bill before I call for the
- 10 roll call vote on that?
- 11 Senator Burr. Mr. Chairman.
- 12 Chairman Sanders. Senator Burr.
- 13 Senator Burr. Mr. Chairman, I understand that the
- 14 recent government shutdown created uncertainty with veterans
- 15 receiving their benefits but I am also concerned about the
- 16 tremendous problems that face VA.
- 17 VA's claims backlogs have gotten worse over the last
- 18 four years. Recent news reports that veterans are still
- 19 waiting for mental health appointments and quality of care
- 20 issues that have resulted in patient harm and death.
- These are all problems VA is trying to correct; and we,
- 22 in our capacity as an oversight Committee, need to examine
- 23 these issues to ensure VA follows through in their promise
- 24 to improve those departments.
- 25 However, I fear that if we advance appropriate all of

- 1 VA spending, this will seriously limit both this authorizing
- 2 Committee and the appropriations committees ability to
- 3 properly conduct oversight.
- 4 So, I will be opposed to this bill today and I would
- 5 urge my colleagues to seriously think, given the difficulty
- 6 that we have with receiving information from the VA today,
- 7 ask yourself what position we will be in once we have
- 8 advanced appropriate and the entire VA budget.
- 9 I thank the Chair.
- 10 Chairman Sanders. Senator Begich.
- 11 Senator Begich. Mr. Chairman, thank you very much. To
- 12 my co-sponsor, Senator Boozman, thank you, and I know we did
- 13 an event a few weeks ago. To see the House also with a very
- 14 similar bill moving forward, it is a smart move to move the
- 15 final piece of the VA budget into advanced appropriations.
- 16 You know, we have a sizable amount already on the
- 17 medical end. But I would just want to respectfully disagree
- 18 with Senator Burr and that is, you know, the best part about
- 19 advance appropriations from my view is that you get more
- 20 time to do oversight. You can actually get deep into the
- 21 questions and the discussion.
- One of the pieces of advanced funding ensures that
- 23 quality of care continues to move forward rather than this
- 24 stop and start that continues to happen with the VA
- 25 especially around disability claims and the claims that they

- 1 make.
- 2 This will help them move forward to ensure that they
- 3 have some predictability which is part of the equation. I
- 4 mean, we do advance funding for PBS. Why can we not do it
- 5 for our veterans? It makes no sense.
- The reality is this will complete what we started a few
- 7 years ago with the medical component and this will complete
- 8 out the whole VA in advance funding, an organization that
- 9 should not be always threatened with our inability at times
- 10 to have full action here.
- 11 The issue about disability claims, we have moved
- 12 forward not in a speed that I think all of us would like but
- 13 a lot better. I think this piece of legislation will ensure
- 14 that they can actually focus on the job ahead of them rather
- 15 than always trying to figure out, are they going to be
- 16 funded, are they not going to be funded, can they hire
- 17 someone if the appropriation does not get through.
- 18 So, I would just encourage my colleagues to actually
- 19 finish out the VA advance funding appropriations bill which
- 20 this is the final piece of it, ensuring that our veterans
- 21 get the quality care they need.
- 22 Chairman Sanders. Further discussion.
- 23 Senator Boozman. No. I understand Senator Burr's
- 24 concerns especially with information and things like that.
- 25 But I do think that can be overcome.

- 1 My problem with the situation that we have now. Our
- 2 appropriations process is not working very well at all. I
- 3 think we all agree with that. We are going to work hard to
- 4 fix that.
- 5 But in the meantime the VA is a huge agency. That, you
- 6 know, has lots of responsibility, has lots of problems to
- 7 solve. When you simply do not know where your budget is,
- 8 that makes for, I think, bad decisions and wasteful
- 9 spending.
- 10 So, for that reason, I am very supportive of us.
- 11 Chairman Sanders. Okay. Further discussion?
- 12 [No response.]
- 13 Chairman Sanders. If not--
- 14 Senator Burr. A recorded vote, Mr. Chairman.
- 15 Chairman Sanders. Okay. The clerk will call the roll.
- 16 This is S. 932.
- 17 The Clerk. Mr. Rockefeller.
- 18 Chairman Sanders. Mr. Rockefeller votes aye by proxy.
- 19 The Clerk. Mrs. Murray.

- 21 are one. The agenda item is agreed to.
- Chairman Sanders. Why do we not go to Senator Brown's
- 23 bill which is S. 1556.
- 24 Senator Brown.
- 25 Senator Brown. Thank you, Mr. Chairman.

- 1 It is a pretty simple issue about collective
- 2 bargaining. The VA medical professionals are not assured
- 3 the right to grieve and negotiate over routine issues
- 4 causing many VA workers to be denied overtime, comp time,
- 5 and weekend premium pay.
- 6 This is simple fix would clarify that VA workers have
- 7 recourse when their rights under pay laws are violated.
- 8 This is not negotiating over rates of pay which are set by
- 9 Congress.
- 10 Under current law and VA policy, VA health
- 11 professionals who are covered by Title 38 do not have the
- 12 same bargaining rights as their counterparts in DOD or other
- 13 federal employees covered by Title 5.
- 14 This bill will lift the existing prohibitions against
- 15 bargaining over routine workplace matters like Title 38 and
- 16 their labor representatives. The routine issues are
- 17 protection for workers on issues like overtime, weekend pay
- 18 scheduling, reassignments, and performance pay.
- 19 I understand Senator Burr has a proposed substitution.
- 20 I understand. I agree our employee should focus on
- 21 providing quality services while at work. I thing the
- 22 history of collective bargaining is that it makes for a
- 23 better workplace. It makes for better workers. It makes
- 24 for better service that those workers carry out. As I said,
- 25 it is extended in other areas of federal government. It

- 1 should also be included at the VA.
- 2 Chairman Sanders. Senator Burr, your enthusiastic
- 3 support for this legislation.
- 4 Senator Burr. Mr. Chairman, thank you. Just a
- 5 clarification. Is it the Chairman's intent to vote the
- 6 bills and then do amendments at the end?
- 7 Chairman Sanders. Yes.
- 8 Senator Burr. Okay. First, to repeat what I said in
- 9 my opening statement, we have not received views or cost
- 10 estimates from the Administration on this bill.
- 11 Second, this bill would allow VA physicians, dentists,
- 12 and nurses the right to collectively bargain not only over
- 13 compensation issues but over all issues affecting their
- 14 performance.
- 15 Under this bill, doctors would be able to collectively
- 16 bargain over things such as professional conduct and
- 17 competence and peer reviews. Both the Obama and the Bush
- 18 Administrations have strongly opposed similar bills
- 19 introduced in the past by my colleague.
- But more importantly, I am concerned that a protracted
- 21 negotiation between VA and medical professionals and the
- 22 interference of a third-party arbitrator could negatively
- 23 impact the delivery of care to veterans.
- So, I am opposed to the bill and I would ask my
- 25 colleagues also to vote no.

- 1 I thank the Chair and would ask for a recorded vote
- 2 when the appropriate time comes.
- 3 Chairman Sanders. Okay. Further discussion?
- 4 [No response.]
- 5 Chairman Sanders. If not, the clerk will call the
- 6 roll. This is Brown S. 1556.
- 7 The Clerk. Mr. Rockefeller.

- 11 are 6. The agenda item is agreed to.
- 12 Chairman Sanders. Okay. Let us go to S. 1604, which
- 13 is Sanders of Veterans Health Care Expansion Act of 2013.
- 14 Very briefly, what this does is a couple of things.
- 15 Right now we have, as I mentioned before, an incredibly
- 16 confusing process in terms of VA health care eligibility
- 17 baseline income.
- So, you could be living in one county in Nebraska and
- 19 somebody lives across the street in another county, and
- 20 eligibility requirements are different, ostensibly because
- 21 the cost of living in the two counties are different. You
- 22 end up with a telephone book all over this country of
- 23 different eligibility requirements.
- I think frankly it does not make a lot of sense on the
- 25 surface but, second of all, what it does for those folks in

- 1 the VA and those people at statewide levels, Nebraska,
- 2 Vermont, or anyplace else, want to bring people into the VA.
- 3 They get up there and they say, okay, we want you to
- 4 come in. It is good quality health care and then people
- 5 say, well, am I eligible? Well, if you lived in this
- 6 county, it is this income; if you live in that county, it is
- 7 that income. It is very, very confusing.
- 8 So, what we have done is two things. We have said we
- 9 are going to simplify the process. And instead of having
- 10 hundreds and hundreds and hundreds of different income
- 11 eligibility requirements, we are going to have one for each
- 12 state and, one for each state. It would be 50. It will be
- 13 the highest level in each state. That is what that does.
- 14 I think it simplifies the process, makes it easier for
- 15 people to come into the system, and will make life easier
- 16 for those people who are concerned about VA outreach.
- 17 This legislation also gets individuals who served in
- 18 combat an additional five years. I think we are all aware
- 19 of the fact that after our people return from Iraq and
- 20 Afghanistan, they have five years of free healthcare.
- 21 We are going to expand that to 10 years and we will
- 22 extend it to members of the National Guard and Reserves who
- 23 might not otherwise have had access to health insurance,
- 24 access to VA health care but also keep them healthy and
- 25 deployment ready.

- 1 Most importantly, I want to reiterate whenever we talk
- 2 about VA health care, this legislation specifically states
- 3 that the top priority for health care services will always
- 4 be given to our disabled and lowest income veterans so their
- 5 care would not be negatively impacted by this expansion.
- 6 That is kind of what this bill does.
- 7 Senator Burr.
- 8 Senator Burr. Mr. Chairman, I have serious concerns
- 9 regarding 1604 because it would provide for a vast expansion
- 10 of VA eligibility and programs.
- Currently, the VA is struggling, not only to meet the
- 12 needs of veterans coming back from conflicts in Iraq and
- 13 Afghanistan but also in dealing with the needs of veterans
- 14 of all eras. So in all good conscience, I
- 15 cannot and will not support any legislation that vastly
- 16 expands VA beyond its current capabilities. I believe an
- 17 expansion now would be simply irresponsible to those
- 18 veterans who are already trying to access needed services
- 19 and are facing delays in mental health and other specialty
- 20 cares that have resulted in patient harm or death at both
- 21 the Atlanta VA and the Columbia VA Medical Center.
- In addition, Mr. Chairman, as I have said in my opening
- 23 statements and so that all of my colleagues know I am going
- 24 to be consistent. I have said this regarding other pieces
- 25 of legislation on today's agenda. I cannot support

- 1 legislation that does not have an offset. If it is not paid
- 2 for, then I think it is irresponsible for us to pass it.
- I thank the Chair and I yield the floor.
- 4 Chairman Sanders. Any further discussion?
- 5 [No response.]
- 6 Chairman Sanders. I am going to do a roll call vote on
- 7 this. If the clerk would call the roll.

- 13 Chairman Sanders. Okay. Next item up it is
- 14 legislation by Senator Nelson, S. 1260, the Veterans
- 15 Conservation Corps Act of 2013.
- Very briefly, we have made progress in the area of
- 17 veterans unemployment with the passage of the VOW to Hire
- 18 Heroes Act, which created important transition, retraining,
- 19 and employment services.
- We have also enhanced education programs and benefits
- 21 available to veterans. These actions are making a real
- 22 impact on the lives of countless veterans by providing them
- 23 with the training and education opportunities they need in
- 24 order to secure meaningful employment.
- The provisions in the Veterans Conservation Corps Act

- 1 would provide the government with additional tools to carry
- 2 out its obligation to ensure our veterans are provided the
- 3 opportunity to successfully transition to the civilian work
- 4 force.
- 5 We continue to find high unemployment rates among
- 6 veterans, especially the youngest generation of our Nation's
- 7 veterans who have served and sacrificed for this country and
- 8 deserve a fair shot at a fulfilling career and the ability
- 9 to support their families and an opportunity to prosper as
- 10 they resume civilian life.
- DOD paid nearly \$1 billion in unemployment last year.
- 12 I am worried that number may grow as we expect approximately
- 13 1 million service members to transition out of the military
- 14 service within the next five years.
- 15 The bottom line here, I would rather pay people to
- 16 work, gain some experience, do something meaningful than
- 17 just get unemployment. So, I think this legislation is a
- 18 good step forward and we would appreciate its passage.
- 19 Senator Burr.
- 20 Senator Burr. Mr. Chairman, as I mentioned in my
- 21 opening statement and at the previous markup in July, we
- 22 have an obligation to pay for any bills that are reported
- 23 out of this Committee.
- 24 S. 1262 fails this test as there is currently no offset
- 25 for the \$600 million in direct spending authority that is

- 1 contained in the bill.
- 2 Mr. Chairman, I would also like to take a moment to
- 3 address several policy concerns I have with the Veterans'
- 4 Service Corps more generally. This bill would establish a
- 5 program with no detail about the number of veterans who
- 6 would be employed, their length of employment, how much they
- 7 would be compensated, or what tangible skills or licenses
- 8 they would retain while participating.
- 9 Last year I asked the VA to provide details regarding
- 10 this bill and the President's Veterans' Job Corps when both
- 11 were considered by the Committee. Although VA insured us
- 12 last year that they would work with the Committee on this
- 13 program and said the same thing during the legislative
- 14 hearing last month, however, this Committee still has no
- 15 idea how this program would function if it ever became law.
- 16 What is needed to address the ongoing issues of
- 17 veterans' unemployment is an effort to assist veterans with
- 18 translating their military skills or help them enter job
- 19 training programs that will place them on track for careers
- 20 and not temporary, low-wage, make-work programs that will do
- 21 nothing to prepare veterans to be competitive in the
- 22 civilian labor market.
- I would urge my colleagues to oppose this, and I yield
- 24 back.
- 25 Chairman Sanders. Okay. Further discussion?

- 17 Chairman Sanders. Okay. The last item on our agenda
- 18 before we get to amendments is a bill represented by Senator
- 19 Jack Reed. The SCRA Enhancement Improvement Act of 2013.
- The ideas incorporated in this legislation are offered
- 21 by an attorney with years of experience litigating SCRA
- 22 matters. They were offered by the Office of Servicemember
- 23 Affairs which has and continues to work tirelessly on behalf
- 24 of servicemembers and veterans.
- This legislation incorporates ideas offered by the

- 1 Department of Justice, the agency charged with enforcement
- 2 of the SCRA, and these ideas are supported by the Military
- 3 Officers Association of America, an organization of over
- 4 380,000 members from every branch of service committed to
- 5 representing the needs of American servicemembers.
- 6 So, I think it is a good piece of legislation. I hope
- 7 we can pass it.
- 8 Senator Burr.
- 9 Senator Burr. Thank you, Mr. Chairman.
- 10 Although this bill has some worthwhile provisions that
- 11 I could personally support, there are coupled with others
- 12 that have not yet gone through a sufficient vetting process,
- 13 particularly when we are changing a law as far-reaching as
- 14 the Servicemembers Civil Relief Act, it is important that we
- 15 understand how well existing protections are working, where
- 16 there are gaps, and the impact intended or unintended of
- 17 possible changes.
- 18 But in this case, the federal agencies most involved
- 19 with the law, including the Department of Defense and the
- 20 Department of Justice, were not at the legislative hearing
- 21 when these provisions were on the agenda.
- Even if they had been, in depth discussions about the
- 23 Servicemembers Civil Relief Act would have been, would not
- 24 have been possible because we were considering 36 bills and
- 25 to date we have not received written views from the agencies

- 1 with their input.
- 2 Also, for many provisions in this bill, we do not have
- 3 studies, reports, or other materials that would help us
- 4 figure out how best to address any gaps in current
- 5 protections.
- In fact, it appears that parts of the bill were crafted
- 7 based simply on a few anecdotes. Although anecdotes can
- 8 provide helpful information about what changes we should
- 9 consider, they should be part of our inquiry, not in the
- 10 end. That is why I plan to offer several amendments that
- 11 would require studies to help us make more deliberative
- 12 informed decisions about what changes are needed.
- Mr. Chairman, the bottom line is that we do not have
- 14 enough information to move forward at this time.
- 15 Chairman Sanders. Okay. Thank you, Senator Burr.
- 16 Further discussion?

- 18 Chairman Sanders. If not, Madam clerk, please call the
- 19 roll.

- Chairman Sanders. Okay. We have dealt with all

- 1 legislative items. Now, we have to get to amendments. Let
- 2 me begin by going to Senator Burr.
- 3 Senator Burr. Mr. Chairman, why do we not take Senator
- 4 Hirono's first.
- 5 Chairman Sanders. Okay. That is very kind of you.
- 6 Senator Hirono, do you want to go first?
- 7 Senator Hirono. Yes. Thank you very much, Senator
- 8 Burr.
- 9 I would like to go up my amendments to S. 1262, the
- 10 Veterans Conservation Corps Act. My amendment would simply
- 11 clarify that governments of the U.S. territories, the
- 12 District of Columbia, and natives serving organizations are
- 13 eligible to apply for the grants made available under this
- 14 bill to help place vets in those areas in jobs.
- 15 I completely agree with you that we pay a lot in
- 16 unemployment benefits to veterans, and I would much prefer
- 17 that we pay them for doing a job. Thank you.
- 18 Chairman Sanders. Well, I strongly support Senator
- 19 Hirono's amendments. She corrects an oversight, and we
- 20 apologize for that. We thank her very much.
- 21 Senator Burr, did you want to comment on that?
- 22 Senator Burr. I am supportive of it. Let us take a
- 23 voice vote.
- 24 Chairman Sanders. A voice vote. All of those in favor
- 25 of the Senator Hirono amendment please say aye.

- 1 [A chorus of ayes.]
- 2 Chairman Sanders. Opposed.
- 3 [No response.]
- 4 Chairman Sanders. The ayes appear to have it. The
- 5 ayes do have it. The amendment is passed.
- 6 Senator Burr.
- 7 Senator Burr. Mr. Chairman. I have amendment number
- 8 one to S. 1593.
- 9 Chairman Sanders. All right. Let me make sure we are
- 10 all on the same page here. Is that is that the original
- 11 numbers?
- 12 Senator Burr. Yes.
- 13 Chairman Sanders. Okay.
- 14 Senator Burr. Mr. Chairman, as currently written,
- 15 Section 104 would amend the Servicemembers Civil Relief Act
- 16 to require that all state and local licensing agencies
- 17 around the country adopt a new policy on renewing a
- 18 professional license held by certain military personnel.
- In concept, I am sure we can all agree that military
- 20 personnel should not lose such a license as a result of
- 21 their service. But when we make changes to the law as far-
- 22 reaching as this, we should first have a full understanding
- 23 of how well existing protections are working where there are
- 24 gaps in the impacts or unintended or intended consequences
- 25 of those changes.

- 1 In this case, we should understand how frequently
- 2 military personnel are unable to renew a professional
- 3 license while on active duty and the reasons why they could
- 4 not comply with state and local requirements.
- In that regard, it appears that many states already
- 6 have policies to make it easier for military personnel to
- 7 maintain a professional license such as delaying continuing
- 8 education requirements or the deferring the need to renew
- 9 the license.
- Before we require an across-the-board change to these
- 11 policies, we should first determine which are working and
- 12 which are not and how best to address any issues military
- 13 personnel face in trying to renew those professional
- 14 licenses.
- 15 But currently, we do not have views from relevant
- 16 federal government, state, and local agencies or other
- 17 stakeholders or reports, studies, or other materials that
- 18 would allow for that type of analysis.
- 19 So, my amendment would strike the changes that Section
- 20 104 would make and instead require GAO to conduct a study on
- 21 the barriers faced by military personnel in maintaining a
- 22 professional license.
- 23 As part of that study, GAO would look at what options
- 24 are available to military personnel to help them comply with
- 25 state and local requirements, how frequently they are unable

- 1 to maintain licenses despite those options, and the reasons
- 2 why they were unable to do so. This should help us figure
- 3 out the extent of any problem and tailor an appropriate fix.
- In fact, this is an approach that the Chairman himself
- 5 has followed in crafting other bills on today's agenda.
- 6 Those bills include a number of studies or reports aimed at
- 7 gathering information to determine whether legislative
- 8 changes may be necessary before we actually change the law.
- 9 Mr. Chairman, this amendment is not meant to suggest
- 10 that I am ruling out the need for legislation to help
- 11 military personnel maintain professional licenses. It is
- 12 simply meant to ensure that we have on the relevant
- 13 information about the possible problems before we move
- 14 forward. And I yield.
- 15 Chairman Sanders. Thank you, Senator Burr.
- 16 Unfortunately, I cannot support this amendment. The
- 17 Committee print would ensure licenses are not canceled
- 18 during a period when a servicemember is receiving hostile
- 19 fire or imminent danger pay.
- It does so without interfering in the standards by
- 21 which a state uses to license and individual. Rather, it
- 22 provides a short period of time following deployment in
- 23 which a servicemember can ensure they meet whatever
- 24 licensing and continuing education requirements a state
- 25 deems appropriate.

- I believe this is a proactive approach to help ensure
- 2 servicemembers, especially members of the National Guard and
- 3 Reserves, have time to smoothly transition back to a
- 4 civilian career following a period of service. I urge my
- 5 colleagues to reject this amendment.
- 6 Unless there is further debate, let us move to a vote
- 7 on this amendment. Is there further debate?
- 8 [No response.]
- 9 Chairman Sanders. If not, clerk will you call the roll
- 10 please.
- 11 The Clerk. Mr. Rockefeller.

- 18 Chairman Sanders. Senator Burr.
- 19 Senator Burr. Mr. Chairman, amendment number two to S.
- 20 1593 to strike the content of Section 107 and instead
- 21 require a study by the General Accounting Office. As
- 22 written, Section 107 would amend the Servicemembers Civil
- 23 Relief Act so that the interest rate cap would apply to
- 24 loans obtained during military service in order to
- 25 consolidate or refinance student loans that were incurred

- 1 before entering the military. This change would apply to
- 2 private student loans and to the federal loan programs such
- 3 as the direct loan consolidation program.
- 4 Before making this type of change, we should first
- 5 understand what programs and protections are already
- 6 available to military personnel, what gaps may exist and the
- 7 impact of any possible changes will.
- 8 At our legislative hearing, the only agency present,
- 9 the VA, simply deferred to the Department of Defense,
- 10 Education, and Justice as well as the Consumer Financial
- 11 Protection Bureau about this provision and the Committee
- 12 still has not received views from the relevant agencies.
- 13 Also, the Federal Government already offers many loan
- 14 repayment, forgiveness, and consolidation options. In fact,
- 15 Congress had a robust debate earlier this year about setting
- 16 interest rates for federal student loan programs.
- 17 That debate centered around the fact that these
- 18 programs are very generous with options based on how much an
- 19 individual earns and the size of the loan, not just based on
- 20 the interest rate.
- 21 At a minimum, we should look into whether this change
- 22 would lead more military personnel to access programs like
- 23 loan consolidation when it is possible they would be better
- 24 off choosing other options such as income-based repayment or
- 25 pay as you earn.

- 1 In sum, I do not think this provision has been
- 2 thoroughly vetted. So, this amendment would strike the
- 3 changes in 107 and instead require GAO to conduct a study on
- 4 the options available to military personnel to manage their
- 5 student loan debt.
- 6 As part of that study, GAO would look at what type of
- 7 programs are already available to military personnel to deal
- 8 with student loan debt, how many military personnel seek to
- 9 access these programs, whether they are aware of their
- 10 rights under the Servicemembers Civil Relief Act and whether
- 11 changes are needed to ensure that military personnel have
- 12 access to the appropriate programs and protections to assist
- 13 with managing their pre-service student loans.
- 14 Mr. Chairman, this amendment like my other amendments
- 15 on this bill is simply meant to ensure that we have all the
- 16 relevant information about the possible problems we might
- 17 face if we move forward with this solution. This is an
- 18 approach of obtaining more information before we change the
- 19 law that was embraced in other bills in today's agenda. I
- 20 yield.
- 21 Chairman Sanders. Senator Burr, thank you very much.
- 22 Unfortunately, I cannot support this amendment.
- The Committee print would prevent servicemembers from
- 24 having to choose between taking advantage of the benefits of
- 25 loan consolidation such as public student loan forgiveness

- 1 and the interest rate limitation of the SCRA.
- 2 This was an issue identified by Holly Petraeus at a
- 3 hearing before this Committee earlier this year.
- 4 Servicemembers should be able to use every available tool
- 5 including the protections of the SCRA to manage student loan
- 6 debt.
- 7 For this reason, I would urge my colleagues to reject
- 8 this amendment.
- 9 Further discussion?
- 10 [No response.]

- 21 Senator Burr. Amendment number three. I am just
- 22 making sure we call it the right number, Mr. Chairman.
- 23 Currently, Section 302 of the Committee bill would
- 24 grant authority to the Department of Justice to issue civil
- 25 investigative demands when investigating possible violations

- 1 of the Servicemembers Civil Relief Act.
- 2 Although the Department of Justice has indicated that
- 3 they would like this authority, it is not clear whether it
- 4 is necessary. In fact, the Justice Department has been
- 5 involved in a number of successful Servicemembers Civil
- 6 Relief Act investigations over the past few years without
- 7 having this authority.
- 8 It is also not clear whether the authorities of Section
- 9 302 contain sufficient protections for the entities that
- 10 maybe the recipient of civil investigative demands.
- 11 For example, it appears that the bill would authorize
- 12 Justice to demand documents and written responses from
- 13 entities who are not themselves under investigation for
- 14 violations of the Servicemembers Civil Relief Act without
- 15 the involvement of a court.
- 16 The bottom line is that before we grant this authority,
- 17 we should learn more about why it may be needed, how it is
- 18 best used, and what the impact would have on both the
- 19 investigations and on the entities that would be the subject
- 20 of these demands.
- 21 So, this amendment would strike Section 302 and instead
- 22 require GAO to conduct a study on investigations conducted
- 23 by the Department of Justice.
- As part of the study, GAO would look at the issues that
- 25 Justice has encountered in investigating possible violations

- 1 because it does not have this authority, steps that have
- 2 been taken to overcome those issues, and how successfully
- 3 they have been and recommendations for improving the ability
- 4 of Justice to conduct Servicemembers Civil Relief Act
- 5 investigations.
- 6 I thank the Chair.
- 7 Chairman Sanders. Thank you, Senator Burr.
- 8 Unfortunately, I cannot support this amendment. The
- 9 Committee print would provide the Department of Justice with
- 10 another important tool to use in enforcing the
- 11 Servicemembers Civil Relief Act.
- 12 As the department pointed out in testimony before this
- 13 Committee last year, when individuals are uncooperative, DOJ
- 14 must undertake costly efforts to obtain the necessary
- 15 evidence through alternative routes or forgo the negation.
- 16 DOJ already has similar authority to enforce other
- 17 statutes such as the False Claims Act. The authority
- 18 provided by the Committee print is narrow in scope. It
- 19 would not allow DOJ to compel oral testimony or sworn
- 20 answers to interrogatories.
- The Committee print also includes a reporting
- 22 requirement so Congress can keep a close watch on DOJ's use
- 23 of this authority. I believe the federal department charged
- 24 with enforcement of the SCRA should have the tools necessary
- 25 to enforce the benefits and protections we provide our

- 1 servicemembers. I urge my colleagues to reject this
- 2 amendment.

- 15 Mr. Chairman, my amendment is very simple. It would
- 16 require that prior to the Secretary of Veterans' Affairs
- 17 implementing the Veterans' Conservation Corps, participating
- 18 agencies would have to certify to Congress that they have
- 19 all taken all practical steps to hire qualified veterans to
- 20 fill vacant permanent positions.
- 21 Federal agencies have several existing hiring
- 22 preferences that allow them to quickly hire qualified
- 23 veterans into the federal service. These preferences
- 24 require no additional legislative action, and it is clear
- 25 that veterans would benefit far more from full-time

- 1 permanent jobs than the temporary positions proposed by this
- 2 bill.
- I urge my colleagues to support this amendment.
- 4 Chairman Sanders. Thank you, Senator Burr.
- I am in opposition to your amendment. I already have
- 6 explained why I voiced my support for this legislation.

- 17 Senator Burr. Mr. Chairman, I call up amendment number
- 18 seven to S. 1556.
- 19 Mr. Chairman, this amendment would replace the text of
- 20 the bill with language that would limit the use of official
- 21 time by VA employees. As some of my colleagues may know,
- 22 official time relates to the practice where federal
- 23 employees are paid by the government to perform union
- 24 duties.
- 25 An alarming number of federal employees spend 100

- 1 percent of their time performing union duties instead of
- 2 serving the mission of the agencies they work for.
- 3 Information doctor Coburn's office shared with my staff
- 4 indicates that in 2012 more than 180 VA employees spent 100
- 5 percent of their time working on union activities. Examples
- 6 of some of the types of VA employees who spent 100 percent
- 7 of their time working on union activities in 2012 include 85
- 8 VA nurses, four addiction specialists, nine pharmacists and
- 9 pharmacist technicians, five social workers, and two
- 10 psychologists.
- 11 VA employees provide vital service to our Nation's
- 12 veterans. It is a slap in the face to veterans to not have
- 13 every dollar we give to the VA used directly to benefit
- 14 their services.
- 15 With our Nation buried in debt, we need to maximize
- 16 taxpayer money we send to the VA. I would encourage my
- 17 colleagues to support this commonsense amendment.
- 18 Chairman Sanders. Further discussion?
- 19 Senator Brown. Mr. Chairman.
- 20 Chairman Sanders. Senator Brown.
- 21 Senator Brown. Thank you, Mr. Chairman.
- I oppose the amendment. We know that there is a long
- 23 history in this country of collective bargaining working for
- 24 workers and working for the service at those workers provide
- 25 and make for a better workplace, make for better workers,

- 1 and make for better service.
- 2 Much of what Mr. Burr speaks about, I believe is
- 3 improving those services and making sure that in these
- 4 nurses are also serving their coworkers in doing their jobs
- 5 better and providing better VA service.
- 6 This will make for a better workplace and I think that
- 7 is only good for veterans and good for the VA. So, I ask
- 8 for our colleagues to vote no.
